CARE AND MAINTENANCE

FRAMES

Cleaning - Use mild soap and warm water. Do not use abrasive materials, cleansers or bleach products. Rinse with clean water and dry thoroughly.

Maintenance - Periodically clean and dry thoroughly. Be sure to drain any water accumulated inside the frames. To thoroughly drain frames, remove foot caps and tilt the frames, if necessary, to remove all water. This is critical. Water allowed to accumulate inside the frames and then exposed to sub-freezing temperatures can cause damage to the frame tubing. Such damage is not covered under warranty. Always clean, drain and dry thoroughly before storing for the winter. For best results, always store or cover your furniture when not in use (furniture cover included). We recommend commercially available outdoor furniture covers. Any small nicks or scratches can be covered with a light application of touch-up paint.

** When cleaning or moving large or heavy items, always have two people work together. Never drag furniture.

FABRICS (CUSHIONS/SLINGS)

Cleaning - Wipe minor spills immediately. Clean with mild soap, warm clean water and a soft cloth. Do not use abrasive materials and cleansers. Although fabric has been treated to resist stains, occasional use of commercially available fabric cleaners may be necessary. Follow manufacturer's instructions.

Maintenance - The best way to maintain the beauty of cushions and slings is to store them in a dry area and out of the elements when not in use, or cover with commercially available outdoor furniture covers.

INSTALLATION


- 1. Carefully unpack all items from the box. Place the base in the final position. There must be a minimum of 24 in / 60.9 cm of clearance from the side of the table top to any combustible walls.
- 2. Place the tabletop on the base. Secure the tabletop to the firepit base using the bolts and washers that are provided. See Figure 3 and Figure 4.



3. Pour the fire ice into the burner pan completely covering the burner. See Figure 5.




4. Remove the cardboard cover from the ignition well as shown in Figure 6.



5. Slide the tank drawer out and place the LP tank in the drawer. Connect the regulator as shown in Figure 7. Screw the black handle clock-wise to tighten. Turn the handle counter clock-wise to remove. The hose must point down. Check that the valve is turned all the way clockwise to the "OFF" position. Open the tank valve. Apply a solution of soapy water to the tank-regulator connection and to the valve-hose connection to check for leaks. If soap bubbles continue to form, the connection has a leak. If a leak is found, close the tank valve and tighten all connections.

6. Tighten threaded knobs (L) found on tank tray (Figure 8) so that the LP tank cannot move from side to side. Do not remove plastic cap from end of threaded section.



NATURAL GAS CONVERSION



Natural gas conversion must be performed only by your natural gas provider or service company.

1. Disconnect the regulator hose from the gas valve. See Figure 9.



- 2. Disconnect the gas tube from the orifice elbow. Remove the two M4 nuts and remove the orifice holder. Replace the propane orifice with the natural gas orifice from the kit and reinstall the orifice holder. Apply a solution of soapy water to all connections to check for leaks. If soap bubbles continue to form, the connection has a leak. If a leak is found, close the main valve and tighten all connections. NEVER USE A FLAME TO CHECK FOR LEAKS.
- 3. Stick the conversion label on the rating plate as shown in Figure 10.

BATTERIES

Make sure the control knob is in the "OFF" position. Unscrew the push button cap on the ignition module located on the control panel to access the battery compartment. The ignition module requires one Alkaline AAA size battery (1.5V). The negative (-) end goes in first. See Figure 11. Dispose of battery safely. Battery may explode or leak if charged or disposed of in fire. Make sure of the polarity. The battery is mercury and cadmium free.



LIGHTING INSTRUCTIONS

Warning: If these instructions are not followed exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- Open the tank drawer and find the control panel on the left. Make sure the control knob is in the "OFF" position. See Figure 12. Open the tank valve all the way.
- 2. Push in the igniter button. You will hear a slight clicking sound. With the igniter button pushed in, push and turn the control knob to the "ON" position. The fire should light within a few seconds. Once the flame is lit, release the igniter button and continue to hold the control knob in for 10 to 15 seconds. Release the control knob. The control knob should pop back out and the fire remain lit. Note: If the fire does not light, turn the knob to the "OFF" position and wait five (5) minutes before trying again.



- 3. To turn down the flame, push the control knob in slightly and turn to Medium (medium flame), or Low (small flame).
- 4. To turn off the fire pit, turn the control knob to the "OFF" position and turn off the tank valve.

BURNER COVER ASSEMBLY

1. Place the burner cover on the table top as shown in Figure 13.

WARNING: BEFORE PLACING THE BURNER COVER ON, MAKE SURE THE FIREPIT HAS BEEN SHUT OFF AND THE BURNER HAS COMPLETELY COOLED DOWN.



MAINTENANCE

The flames should look like those in Figure 14. To clean the burner, use a soft brush after the burner has cooled completely. Never use a vacuum cleaner on the burner. It is recommended to store the fire pit indoors during winter if it will be subjected to freezing temperatures. The LP cylinder must be disconnected and removed from the appliance before the appliance can be stored indoors.
